a. Maintenance issues:

i. We have been working with Tuff Trailer to make the modifications on the LC 351 trailer to better support the vessel. They will be providing outriggers and bunk board that we can install. Munson Boats is working with Tuff Trailer to cover these costs.

ii. Van Bortel Ford has told us that the caps for the four new Ford F-350 trucks are expected around October 2023.

iii. PB 400 shaft repair work. Stormy Bay Marine Services has the new propeller shafts and is being strongly encouraged to get this work done so the boat can go back on mission at Indian Point.

iv. PB 300 remains NMC due to port power head oil seal failure, and now replacement of lower end. ETR is 1OCT23.

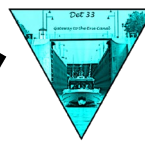
